Public Participation

Gloria Walden was not present, so Mayor Trulock said we would continue with the next item on the agenda.

Reports

MEAG Year End Settlement Report

Mayor Trulock told the Council we had received the year end settlement report from MEAG for the year 2021 and the City's allotment is \$33,175. He stated that the past few years, we have deposited the Y.E.S. in the Intermediate Term Portfolio. Trey Gainous made a motion to deposit the Year End Settlement into the Intermediate Term Portfolio. Joel Singletary seconded the motion. All members present voted in favor of the motion. Motion carried.

ARPA

City Clerk Rogers reported that she had sent references from the Final Guidelines for the American Rescue Plan Act (ARPA) to City Attorney Charlie Ferenchick to make sure the City could purchase the AMI Nighthawk meters with the ARPA funds and Attorney Ferenchick confirmed the meters would be covered under the guidelines. Utilities Director Ausburn stated that Nighthawk could start the ordering process as soon as we give them the go ahead. Trey Gainous made a motion to approve the purchase of the Nighthawk meters with the ARPA money. Joel Singletary seconded the motion. All members present voted in favor of the motion. Motion carried.

Council Member Recommendations

Mr. Andrew Walden informed the Mayor and Council that the Ebenezer Community Outreach will host their Easter even on Easter Sunday at 3:00 PM. The Waldens had been inquiring with the National Register about getting a plaque placed for the church building to recognize it as a National Historic building. The National Register told Mrs. Walden to talk to the Council and meet with the Grady Historic Society. Mayor Trulock said he would also make some phone calls to get more information on the process. Mr. and Mrs. Walden thanked the Mayor and Council for allowing them to speak at the meeting and left the meeting.

Council Matters of Interest

Jim Sellers asked if we could see if the Boy Scouts would be interested in cleaning street signs for a community service project. Mayor Trulock stated he would talk to the Scoutmaster to inquire about this potential project.

Mayor Trulock stated paving project is still on, we are just waiting on the City of Bainbridge. Utilities Director Ausburn stated when the weather warmed up it would better our chances of getting the project done.

Robert Porter was sworn in via oath by City Clerk Rachel Rogers.
