The Whigham City Council met in regular session on Tuesday, June 9, 2020 at 7:00 PM with Mayor George Trulock presiding. Trulock opened the meeting with a prayer and led the Pledge of Allegiance to the Flag.

### **Agenda Adoption**

Motion was made by Jim Sellers to adopt the agenda as presented. Trey Gainous seconded the motion. All members present voted in favor of the motion. Motion carried.

# **Approval of Minutes**

A motion to approve the minutes of the March 28, 2020 called meeting and April 14, 2020 regular meeting was made by Trey Gainous. Motion was seconded by Joel Singletary. All members present voted in favor. Motion carried.

# **Public Hearing**

The City Council reviewed a request from Dollar General Stores for a beer and wine license at the Whigham Dollar General Store. Application has been submitted, fees paid, and Tracy Young has been fingerprinted. Per the City Clerk, the City is waiting for the results from the fingerprints. A motion was made by Dusty Brown to approve the beer and wine license for Dollar General, contingent upon a clean background check. Trey Gainous seconded the motion. Dusty Brown, Trey Gainous, Joel Singletary and Jim Sellers voted in favor of the motion. Motion carried.

#### Reports

Council received the Police Report for April and May. They also received the Utility Director's monthly report.

Mayor Trulock told the Council Becky at K & S of Whigham has inquired about selling beer on Sunday. Mayor Trulock stated he thought that would require a referendum. He will consult with the City attorney.

**2020/2021 Proposed Budget** - Mayor Trulock presented the Council with a proposed budget for 2020/2021. Traditional pay raises included in the budget and \$10,000 Mayor's discretionary fund. No TSPLOST budget or SPLOST budget included in the proposed budget.
